MIN 01/11 – PRELIMINARIES

- The chairman called the meeting to order at 9.18pm.
- The meeting was opened by a word of prayer by **Ooko Aboso**.
- The chairman read the agenda.

MIN 02/11 – READING AND CONFIRMATION OF THE MINUTES

- The members present at the meeting adopted the minutes after being proposed by Jakob Ondiko and seconded by Penina Odongo.

MIN 03/11 – THE CASE OF JACK ODONGO

- Penina Odongo and Jack Odongo informed members about the court case that Jack Odongo was involved in.
- The members agreed to contribute whatever they have in order to help Jack Odongo handle the case well.

MIN 04/11 – CONTRIBUTIONS FOR OTHER FUNERALS

- Majority of the members agreed to contribute Ksh. 300/= for funerals of the relatives of the welfare members who are not members of the Kano welfare.
- Members agreed that all members are required to contribute to all the funerals.

MIN 05/11 FUNERALS

- The members were informed that the group members were contributing to the funerals for relatives of the following members: Erick Akello, Odhiambo Onyuka, **Javiet Obonyo**.
- Members were informed that Mr. Agumba Oyoo has lost his wife and contributions will be conducted as per the welfare by-laws.

MIN 06/11 – SAVINGS

- Members agreed that the savings in the bank are members personal savings and that the contributions shall not be used for any other expenditure except for an investment agreed upon by the members.
- Members agreed to make monthly contributions to improve the personal savings in the bank.

MIN 07/11 – GROUP REGISTRATION

- The secretary (Elvis Ondiko) informed the members that the group has been registered and that he has kept the certificate.

MIN 08/11 – CONFLICTING AGREEMENTS AT MEETINGS

- The members agreed to ensure consistency in the agreements of the online and the physical meetings to avoid conflicting positions.
- The members agreed that the minutes of the online meeting shall be read to members attending the physical meetings at home in Ongoche.
- The members agreed that the minutes of the physical meeting shall be read to members attending the online meeting.
- Members agreed that all minutes shall be posted online for all members.

MIN 09/11 – PENALTIES FOR NON-CONTRIBUTION

- Members agreed that all members of the Kano welfare self help group should contribute to funerals as agreed without failure.
- The members agreed that any member who does not contribute but ends up having a problem or a funeral shall be penalized or fined by making the person contribute all the missed contributions before the members contribute for him or her.
- Members agreed that all the contributions from fines and penalties shall be deposited in the group account and that the penalty contribution will belong to the welfare.

MIN 10/11 – MEMBERS ATTENDING FUNERALS

- The members agreed that to avoid challenges arising from large numbers attending funerals of relatives who are not members of the Kano group, the funerals shall only be attended by members who have contributed Ksh. 300/=.

MIN 11/11 – AOB

- Elvis informed members that the memorial for Owigo Ondiko will be held on 30th December 2025.
- Elvis made a request for contributions towards the celebration of Owigo's memorial.
- The chairman informed the members that there will be a physical meeting at home in Ongoche on 30th November 2025.
- The chairman informed the members that there will be an online meeting on the 30th November 2025 at 9.00pm to make follow-up on the resolutions of the physical meeting and to update members on the progress of the undoing contributions.
- Ooko Aboso informed members about the Tuishi Funeral Programme that requires Ksh. 200 monthly contribution and provides the following assistance during funerals: Payment of part of the cost of mortuary, payment of the cost of transport, and payment of cost of tents and chairs.
- The officials were advised to get in touch with Jerry Agumba and advise him to cooperate and contribute towards the problems that are faced by members.
- The secretary and the treasurer were advised to have book records of all contributions to help in tracking non-paying members.
- The treasurer was advised to post the EXCEL sheet record of members savings on a monthly basis.

- The meeting was adjourned at 11.00pm.
